

**Town of Rich Square**

**PLANNING BOARD and Other Committees**

**APPLICATION**

The Board of Commissioners of the Town of Rich Square is seeking volunteers to appoint and serve on the Town’s Planning Board to: (1) participate in and assist in developing the community’s Land Use Plan, (2) review and make recommendations on development proposals, and (3) to participate in and assist with reviewing and updating the Town’s land use regulations, which will carry out the Town’s land use vision and strategies.

The Planning Board will meet an average of once per month. You will be provided orientation on your expected activities, educational information, and a copy of the Town’s two land use regulations.

Note: If you are interested in serving, the Town also needs members to serve as Board of Adjustment, whose function is somewhat different from the Planning Board. It serves as a “judicial panel” on cases relating to some aspect of the Zoning Ordinance. It does not meet each month - only when a case is submitted, which is infrequent. Would you be willing to serve on this Board?
